#### MINUTES FROM THE NOVEMBER MEETING

Lorraine Watry started her demonstration at 6:30. Tonight she is demonstrating how she paints hummingbird wings so that they look like they are moving. She showed us the techniques she uses to show motion. One is by blurring the wing and the other is to change value and color. Lorraine prefers Daniel Smith paints because of their intensity of color. Dry the back edge of your brush with a paper towel to have better control of color. Lorraine always stretches her watercolor paper, and you can find out how to do that on You Tube. Thank you, Lorraine for a very informative demonstration.

The business meeting was started at 7:30 by President Mary Cotner. Secretary Mary Burke asked for any additions or corrections to the last meetings minutes and there were none. Treasurer Cheryl Pennington gave her report. Balance 9/28/18....6335.70 Balance 10/31/18...5984.95. Treasurer's report was approved. Cheryl then handed out the proposed budget to all members. Virginia Craig made a motion to change our format, seconded by Janet Garoutte. Motion carried unanimously. Annette McGuire sold 3 paintings in Oct. and took a place at Steel City Show and was accepted into the Kansas Watercolor Show and took a 1<sup>st</sup> place at the Pueblo Art Guild Nature Show. Cheryl Pennington will be the featured artist at the Hive in Canon City in December and. she also won 1st place at the Pueblo Art Guild Show. Lori Dickerman sold 2 pieces at the Blue Spruce and won a Patron's award at "Paint the Town" event in Florence. Congratulations to all. Lynette Holmes handed out information on the handwoven show at the Vail Hotel.


Motion to adjourn was made by Janet Garoutte and seconded by Jesse Duran. Meeting adjourned at 8:15.
